AMENDMENT TO FEES AND CHARGES 2013/2014

BYRON BAY NEW YEAR'S EVE

Road Closures and Parking Restrictions

Byron Shire Council has resolved to implement various parking and traffic management changes in Byron Bay during the 2013–2014 Christmas – New Year period. These include the following.

Road closures in Byron Bay commence from 6am 31 December 2013 and conclude by 6am 1 January 2014 and will occur on:

- Jonson Street, between Lawson Street and Marvell Street and
- Byron Street, between Jonson Street and Fletcher Street

Signed detours will be available and delays can be expected. Avoid driving if possible. These closures are required to facilitate the market stalls and "Soul Street" festivities.

Special Event Parking Area (SEPA) will be signed and apply 26 December 2013 to 6 January 2014 inclusive which applies a 2P parking time limit to all untimed roads and road related areas that exist between:

- Ewingsdale Road, from Belongil Creek Bridge;
- Bangalow Road, from the west side of Old Bangalow Road; and
- Broken Head Road, from approximately 220m south of Bangalow Road.

The 2P time limit applies unless other parking laws apply, for example 1P or another time limit or restriction (eg No Parking) is signed, or you are a "Permit Holder" which is any vehicle that displays a valid Byron Shire "Resident Parking Coupon" as affixed to the vehicle in accordance with the instructions as printed upon the coupon.
